# REGULATIONS FOR THE CREATION AND GOVERNANCE OF UNIVERSITY CLUBS

#### **INTRODUCTION**

CUNEF Universidad offers students the option of taking part in different extracurricular activities, to complement the education they receive in the classroom and enrich their university experience. Additionally, these activities aim to provide students with transversal skills, make their education more comprehensive, and enhance values such as excellence and sustainability, which CUNEF Universidad promotes and encourages.

This regulation of CUNEF Universidad's University Clubs has been drafted according to Organic Law 4/2007, of 12 April, which modifies OL 6/2001, of 21 December, on Universities, which in Section 14 focuses on sports, university outreach, and activities that foster cooperation and the promotion of university culture, and Royal Decree 1791/2010, of 30 December, approving the University Student Statute, which regulates student participation activities in Article 38.

#### **ART. 1 DEFINITION OF A UNIVERSITY CLUB**

CUNEF Universidad undergraduate or graduate students may set up Clubs aimed at conducting activities that promote intellectual and cultural development, the exchange of opinions and the practice of sports, always abiding by the higher values of our society and, especially, those advocated by CUNEF Universidad. The Clubs will also foster volunteering.

#### **ART. 2 CREATION**

A minimum of 20 students is required to create a Club.

The Club Charter must specify the details of every student member, including the undergraduate or graduate programme they are studying, and the name of the student who has been chosen Club Representative. It will also describe the purposes of the Club and the type of activities it will promote.

#### **ART. 3 RECOGNITION**

Once a Club has been created, its Representative will apply for recognition from the Academic Coordinating Committee through the Club Coordinator. The Club Charter must be attached to the application.

If their application for recognition is rejected, they may appeal this decision before the Vice-Rector for Academic Planning and Quality Assurance.

The Academic Coordinating Committee may strip a Club of such status if its actions are against the values promoted by CUNEF Universidad or the Law.

#### **ART. 4 ORGANISATION AND OPERATION**

When they agree to create a Club (as specified in article 2), the members will elect a Club Representative for a term of one academic year, extendable if a majority of the members agree.

The Representative will represent the Club before CUNEF Universidad and will be in charge of coordinating the Club's activities and seeing to their proper functioning.

The Academic Coordinating Committee will be tasked with providing the material support needed by the Club to carry out its activities and for recognising credits for participation, according to the requirements set out in CUNEF Universidad's Credit Recognition and Transfer Regulations.
